

Our History

It started with one survivor who took years to finally leave. While setting up her and her children's new life, She kept hearing an inner voice that wanted to create a WAAVE, a wave of women Working Against Abuse, Violence and Entitlement. She envisioned a powerful wave of thousands of women fighting against the upsurge of the insistent belief held by some men, their families and others in society that it is justifiable and acceptable to abuse women because they deserve it. For her, there was not enough being done to counter the sense of entitlement of the perpetrator and their families. They were not being held to account.

A few years later, her anger was subsiding and her focus shifted to wanting to highlight how women and children successfully rebuilt their lives after domestic violence. The Book Broken to Brilliant - Breaking Free to be you after domestic violence was a result of taking action and believing there is a reason for living through the abuse.

It wasn't just another book, it supported the launch of Broken to Brilliant™ LTD, a registered charity organisation where survivors mentor survivors creating positive new life chapters after domestic violence. It is a pay-it-forward model with coaching, mentoring, workshops, work experience placements, publishing and success centres.

Broken to Brilliant will help victims move to being survivors by acknowledging, appreciating, validating and embodying their accomplishments and rebuilding successful lives. Through the stories of battling abuse – being broken and nearly defeated – to break through to reveal their true self, their inner brilliance. Broken to Brilliant will amaze you with the survivor's courage and reveal how to break through and shine, so you can be free to be you.

Broken to Brilliant: A QLD women's guide to surviving domestic violence

One in four Queensland women are victims of domestic violence.

For those lucky enough to escape, what next? where do you turn and how do you begin to rebuild your life?

Broken to Brilliant is a new book written by four Queensland women; each a former victim of domestic violence.

Essentially, it's a guide written by survivors for survivors.

People think once you're out, you're out, you're free says co-author Paula (not her real name); but that isn't necessarily the case.

"It's that psychological & inner confidence and the belief in yourself and be able to take those steps financially, personally, psychologically and emotionally to be able to rebuild"

"That's where we feel the gap is in the long-term recovery and that's what this book is to help people achieve."

Broken to Brilliant: Survivors launch handbook to escape violence Madonna King

This is a tale of untold perseverance: a lesson for our children in never giving up; a lesson for many of us on how fortunate we are; and a revelation of the immeasurable cost brought on by the epidemic in domestic violence.

But mostly, it's an uplifting tale of how a group of women escaped their perpetrators, sometimes at the risk of death, to give themselves and their children a new start.

And how they, now, have put pen to paper to make that path a teeny-weeny bit easier for all those who follow them.

When penning their own story got too much, they re-read the dedication that now heralds the start of their book *Broken to Brilliant*. It reads: "This isn't just another book; it is from survivors dedicated to fellow domestic violence survivors. May each page you turn guide you to a new chapter in your life".

This is a group of Queensland women who - without the fanfare of a big government review, or the support of deep pockets - have chronicled a guide for others escaping the brutal force being waged behind closed doors in our suburbs.

Planned budgets, with details of how much everything from stamp duty to paint brushes cost, are included, alongside guides to self-health, and a long list of emergency contact numbers.

Broken to Brilliant could only have been written by survivors of domestic violence.

Like one woman, who trained as a nurse, and recalls a tutorial on domestic violence. "As we all sat crossed legged on the floor and discussed the case study, my response was - 'I am too strong for that to happen to me, I would walk out'."

But she didn't. She continued to live with her abuser; her decision to leave taking years. But after reading her story, you can't ever again judge those who stay.

Or another woman, who as a 21-year-old met "and fell head-over-heels in love with a charming and very attentive 24-year-old guy". She left when she was 38; a sad, broken and terrified mother with children to protect.

Her partner would delight in looking over maps in front of her, pointing out disused mineshafts and explaining how a dead body could be dumped down a mineshaft and never be found. "Even if it were, he'd say 'If you burn it, then they can't see the DNA to identify the body'."

From the outside, and with few friends after living in 15 different homes in 13 years, they looked like the perfect couple. She thought he was planning the perfect murder.

Another woman tells of the time she was raped, at the age of 14, by a senior boy who has probably now got his own child. I wonder if he ever lies in bed, at night, knowing what he did to a soft, strong woman who has now reclaimed her life?

The stories go on, giving life to statistics that show of all Australian women, aged 18 to 24, 23,584 reported in one survey that they had experienced sexual assault in the previous 12 months. (And of course, men suffer domestic violence too, but not to the same levels.)

"This equates to 64 sexual assaults per day, which is nearly three every hour," *Broken to Brilliant* says.

As concerning are the figures that 61 per cent of those who experienced violence from someone they knew had children in their care at that time, and more than half never contacted police. One-quarter never sought advice or support.

Broken to Brilliant (you can pick up a copy on Amazon) will be released in Brisbane Thursday night, launching a similarly-named registered new charity where survivors mentor survivors of domestic violence.

It deserves our personal and political support; and these women our utmost respect.

INDEPENDENT AUDITOR'S REPORT

To the Members of Broken to Brilliant Limited

I have audited the financial report of Broken to Brilliant Limited which comprises Statement of Financial Position as at 30 June 2016, and the Statement of Financial Performance and Statement of Cash Flows for the year ended and notes to the financial statements, including a summary of significant accounting policies and Director's Declaration.

In my opinion, except for the qualifications below, the accompanying financial report gives a true and fair view of the Company's financial position as at 30 June 2016 and of its performance for the year then ended in accordance with the requirements prescribed by Division 60of the *Australian Charities and Notfor—profits Commission Act 2012* (ACNC Act).

Qualification

As common for organisations of this type, donations are a significant source of revenue for the Company. The Company has determined that it is impracticable to establish complete control over the collection of donations prior to entry into its financial records. Accordingly, as the evidence available to me regarding fundraising revenue was limited, my audit procedures with respect to receipts had to be restricted to the amounts recorded in the financial records. I am therefore unable to express an opinion whether receipts the Company recorded are complete.

The audit opinion expressed in this report has been formed on the above basis.

Basis for Opinion

I have conducted my audit in accordance with Australian Auditing Standards. My responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Report* section of my report. I have fulfilled my ethical responsibilities in accordance with the Accounting Professional and Ethical Standard's APES 110 Code of Ethics for Professional Accountants.

I believe that the audit evidence I have obtained is sufficient and appropriate to provide a basis for my audit opinion.

Emphasis of Matter

The financial report has been prepared for the purpose of fulfilling the Directors' financial reporting responsibilities under the ACNC Act. As a result, the financial statements may not be suitable for another purpose.

Responsibilities of the Directors for the Financial Report

The Directors of the company are responsible for the preparation and fair presentation of the financial report in accordance with the financial reporting requirements of the ACNC Act and for such internal control as the Directors determine is necessary to enable the preparation and fair presentation of a financial report that gives a true and fair view and is free from material misstatement, whether due to fraud or error.

In preparing the financial report, the Directors are responsible for assessing the Company's ability to continue as a going concern, disclosing, as applicable, matters relating to going concern and using the going concern basis of accounting unless the Directors either intend to liquidate the Company or cease operations, or have no realistic alternative but to do so.

Those charged with governance are responsible for overseeing the Company's financial reporting process.

Auditor's responsibility for the audit of the financial report

My objectives are to obtain reasonable assurance about whether the financial report as a whole is free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes my opinion. Reasonable assurance is a high level of assurance, but is not a guarantee that an audit conducted in accordance with the Australian Auditing Standards will always detect a material misstatement when it exists. Misstatements can arise from fraud or error and are considered to be material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of user taken on the basis of this financial report.

We have compiled the accompanying special purpose financial statements of Broken to Brilliant Ltd, which comprise the Statement of Profit or Loss and Other Comprehensive Income, Statement of Changes in Equity, Statement of Cash Flows and Statement of Financial Position as at 30 June 2016, a summary of significant accounting policies and other explanatory notes. The specific purpose for which the special purpose financial statements have been prepared is set out in Note 1 to the financial statements.

The Responsibility of the Director of Broken to Brilliant Ltd

The director of Broken to Brilliant Ltd is solely responsible for the information contained in the special purpose financial statements, the reliability, accuracy and completeness of the information and for the determination that the significant accounting policies adopted as set out in Note 1 to the financial statements are appropriate to meet the director's needs and for the purpose that the financial statements were prepared.

Our Responsibility


